Tragically, about 95% of today's tobacco users started using before the age of 21. E-cigarette use among Wisconsin high schoolers has increased by 154 percent between 2014 – 2018. N-O-T is an evidence-based program with an impressive success rate, where approximately 90 percent of teens who, have participated in the program, cut back, or quit tobacco all together. - Stop or reduce the amount of tobacco used
- Increase healthy lifestyle behaviors
- Enhance their sense of self-control
- Improve life skills such as stress management, decision making, coping, and interpersonal skills

### Who can apply for a facilitator training scholarship?

Any school/community organization or individual in Wisconsin who wishes to provide assistance to teens who want to quit tobacco or vape use through implementation of the N-O-T program

### Facilitator training scholarship requirements:

- Complete the self-paced, on demand, online (approx. 6-7 hours) N-O-T facilitator training within 30 days of receipt of scholarship code
- ➤ Adhere to the N-O-T mission and program structure
- Implement one N-O-T program within 12 months of completing the N-O-T facilitator training in consultation with Lung Association N-O-T program staff
- Submit completed participant and facilitator evaluations online

American Lung Association staff are committed to assisting schools/community organizations and N-O-T facilitators with specific and customized technical assistance in accordance with the unique needs of each program site.
